6. Plan options for Shady Oak Lane road repair

Chair Wilz

- Review of Shady Oak Lane road construction costs
 - o 2 year project began in 2021
 - Estimated project cost with Hull doing all work was \$66,700
 - Estimated cost of work done in 2021 by Hull was \$28,500
 - Estimated cost of work to be done in 2022 is \$35,500
 - Shady Oak is a little less than a mile approximate ½ of work was done in
 2021
- Request and additional cost of \$27,150 to hire, from Stuczynski Trucking, two men and two trucks for 15 days @ \$1,100.00 per day (\$110 an hour)
- ➤ Motion Supervisor Fritsche, to authorize spending an estimated additional \$27,150 to the original plan of \$66,700 for Shady Oak Lane road construction. Second by Supervisor Way.
