 - > Dave Wilz- Goes over and explains Hiring Temp Replacement Paper.

 - *Jim Kalpinski* board members working long term should get paid.
 - Jim Warner- Board members should be helping in Polls

- > Dave Wilz- Posted three different times to let town people know. Board can make all decisions opportunity for Public Input.
- ➤ Judy was not reapproved as Town Clerk. Reached out to Janet Wolle, previous retired Clerk. She is expected to help part-time only. Janet requested Barb come back as needed to help her. Barb is also retired and is on the Town Board and cannot get paid current.
 - Need to hire long term Clerk, this set up is only temporary.
- > Dave Wilz- reaching out to TOH people first is best but still need the part time help from board members.
- ➤ Mark Fritsche- WTA states board members can only make \$15,000 a year on top of the board member pay.
 - *Jim Warner* If town goes with Barb she has to be careful to not exceed the 15k limit.
 - Dave Wilz- will not be a problem
 - *Jim Kalpinski* hard to find good people to work.
- ➤ Motion to Approve Modification to Change Policy

- > Dave Wilz suggest \$23 per hour. Barb needs to help with office temporarily until not needed. Barb is currently helping Janet. Barb needs back pay for time worked. Barb's last pay rate was \$23 per hour.
 - Dave Wilz- Barb \$23 per hour is for expertise
 - Robin Lipski agrees that pay should be discussed.
 - More discussion on pay differences Kim and Desiree make much less than Barb and Janet because of the years of service they have put in with the TOH.
- > Jim Warner- concerned \$23 per hour will add up too fast
 - Barb only here when needed.
