- > High capacity wells not a lot of concern when there is not a lot of people around
- ➤ Where a lot of people around (such as Well #11) there is a real concern
- Diesel fund fuel not a big deal gasoline can contaminate
- > Other contaminates from agriculture areas, septic systems or lawn fertilizers
- Necessary to determine how water moves
- Water is a valuable element compound

- Find out what can afford to accomplish
- 1 Municipal Building remodel/addition first
- Fire Department next
- Potential floor plans drawn up (3 different)
- Look at 30' expansion to the south
- 1 Accommodate needs in that foot print
- Upgrade existing restrooms too costly to move
- Utilize current offices
- 1 Storage double fire stop dry wall (used at Town of Stockton)
- 1 In floor heat??
- 1 Amount of insulation; energy efficient
- Costs in 2010: \$35 sq ft for remodeling; \$75 sq ft new building
- 1 Half of building for meeting room
- 1 60 to 70 people
- Put another door in (double door) will increase the number of people allowed to be in building as per fire code
- 1 Solves problem with voting
- Talked about including Pete's office in here decided not a good idea as coming and going from work area
 - Pete would like a small window in his office
- 2 of the 3 plans show storage areas possibly half could be for storage and the other half for break room
- 1 Decide on use/purposes of building make available to other groups??
- 1 Have a drawing showing a slanted roof to the front

M Bembenek:

- ✓ Village of Rosholt
- ✓ Was looking to remodel village building.
- ✓ Due to low interest rates now looking to eliminate current building with a new construction
- ✓ Add on 3,600 sq ft

- Hull look to add pm 2,100 sq ft
- 1 Double size of what currently have

Marilynn Kranig – have an office for the Chairperson, Clerk, Treasurer and Assessor. Where is the office for part-time clerical?

D Pederson – in the "open office" area..

D Wilz:

- ➤ If a little short of area and have opportunity, go 30' south and also expand to the west
- Recommend windows in east wall
- How utilize meeting room?
- Look at possibility of 2nd story for storage, etc
- Get cost estimates and work back (quotes from different banks)
- Do 5 year budget projection see what kind of debt load can handle
- Time line for building, shovel ready by spring

Motion Supervisor Syens, second Supervisor Wilz, <u>authorize Dave Pederson and Mel</u>
<u>Bembenek contact builders to get design cost proposal including the possibility of a 2nd story.</u>
Feedback from Hull staff is also to be obtained.
