- ATV's have license or tag
- Only asking for 4-wheeler trails on public roads

J Wav:

✓ Has concerns with the amount of bikers, walkers and runners Hull has on Wilshire Dr.

Citizen from Torun Road – vehicle has to give right-of-way to bikers, walkers and runners

L Pukrop – Wilshire Drive is not a destination road

J Way – do not want war between 4-wheelers, bikers and cars

Should go to Hull's Plan Commission for review

Resident – in summer listen to Harley Davidsons on roads. 4-wheelers are quiet.

D Wilz – at a Wisconsin Town's Association meeting in November, the sheriff was present and stated noise is more of a factor than speed.

- Need data, road counts
- Hull also has Green Circle Trail
- Hull also has Road Committee that needs to review the request

D Wilz – shop around for boots

Pete Kaminski – will take money from roads maintenance budget

Motion Supervisor Wilz, <u>approve purchase of insulated work boots for Hull road</u> <u>crew and purchase of ice cleats. Before purchase bring costs back for Dave Wilz or John Holdridge to look at costs. Funding covered within the road maintenance <u>budget</u>. Second by Supervisor Koshnick. Motion carried by voice vote.</u>

D Wilz – remove Staff in paragraph 2 and replace with Department

J Wolle – is this policy taking away the Fire Department ability to sell items to other Fire Departments?

Board - yes

D Pederson – idea behind this policy was to have a full-time person responsible.

Wolle – the Fire Department has specialized equipment/items and should be doing descriptions.

✓ Pete are you going to do all of the work as outlined in the policy or is Barb going to end up doing the work

P Kaminski – do not put things on Hull's website or Craig's list, Barb would have to do that

P Kaminski – have never heard of municipalities selling their street signs and do not think it is a good idea.

J Wolle - Currently we have one person who has purchased street signs. I believe sales of street signs should not be made to individuals. The town should take signs to businesses that recycle aluminum-we receive funds for the aluminum by weight.

Paragraph 3 of policy, end of first sentence should add "and also use expertise of other department heads".

Jim Kruziki – need to word the policy correctly and coordinate disposal of equipment.

Mark Fritsche – fire hoses are tested. When no longer usable the department gets rid of them. Can we continue to do that? We can cut up the hose and cut off the end pieces for sale.

Motion Supervisor Wilz, table action on policy re: Disposal of Materials and Small Equipment and take back to Ordinance/Policy Group. Second by Supervisor Way. Motion carried by voice vote.

I propose we make the following changes:

- 1. River Cities--close the Money Market account and and transfer \$380,236 to open a 24 month CD which pays 2.5% interest; transfer \$158,000 from Money Market and transfer General savings of \$15,000 to new Hunting CD. Jim suggest transfer bulk of savings and convert to CD's
- 2. Huntington Bank-- Open a 19 month CD account paying 2.6% interest; deposit \$400,000 using funds from River Cities and Chase Banks. Jim learned that Huntington Bank is being bought out by Associated Bank.
- 3. Investors Bank--keep the Money Market account open with the balance of \$406,370. Jim - suggests depositing an additional \$200,000 in Investors Bank.
- 4. Chase Bank-- transfer \$227,000 from General Business Savings to Hunting Bank CD; keep any remaining daily working balances in Chase Checking;

Interest we earned in 2018 totaled \$14,358. If the interest rates remain fixed at current levels we could expect to earn \$29,293 in 2019, an increase of \$14,935.

J Way – pursue the goal to achieve increase in interest as noted on the memo.

D Wilz – Jim to advise when move is made between Huntington and Associated.

Motion Supervisor Way, <u>table to January 23, 2019 meeting.</u> Second by Supervisor Koshnick. Motion carried by voice vote.

Disposal of Materials & Small Equipment – Action tabled.

POLICY FOR DISPOSAL OF MATERALS AND SMALL EQUIPMENT

It shall be the policy of the Hull Board of Supervisors to dispose of unused materials and small equipment by listing for sale on the Town of Hull website and other sites offering items for sale. All items must be available for **public sale**.

The Town of Hull Road Foreman shall be in charge of and manage the disposal of all material and small equipment to be disposed of including but not limited to Road

<u>Department, Fire Department and Office Staff.</u> Small equipment will be defined as having an established value of \$1,000 or less. Equipment valued over \$1,000 shall be disposed of at the discretion of the Hull Board of Supervisors.

It shall be the responsibility of the Hull Road Foreman to determine the cost of items for sale. When possible, cost of a like item shall be obtained from two dependable sites/individuals.

In addition, the Hull Road Foreman shall write a description of the item(s) to be placed up for sale.

Furthermore, it shall be the responsibility of the Hull Road Foreman to determine the length of time items will be available for public sale. After that time, it shall be the Road Foreman's responsibility to determine how to dispose of the items at the best price(s) available to the Town of Hull.

Discarded Hull street signs shall be made available for sale to the public at \$5 each and marked to indicate no discarded sign can be used for official use. All receipts from the sale of equipment will go to the Town of Hull.

Disposal of Wood – approved with removal of BY-PRODUCTS

Policy for Disposal of Wood

The Hull Road Crew will periodically cut trees from Hull Parks and Right-of-Way. Such cutting will be done selectively and after careful review by the Hull Road Crew. Contiguous landowners will first be offered the wood.

Trees and wood by-products will be taken to the Hull Municipal Building. After collection of trees and by-products reach a sufficient quantity, the pile will be advertised and sold to the highest bidder. Separate piles for sale, will be established, for hardwood and softwood.

Hauling of wood will be done by the successful bidder. There will be no cutting, splitting or sawing of wood at the Hull Municipal Building or lot. Loading and hauling of wood will be done by the successful bidder.

No Hull staff will take disposed wood for their personal use.

Hull Road Foreman will be in charge of the collection and the disposal process.
