Subject of Board Meeting: ATV Ordinance- Discussion and Possible Changes (Work Group)

- Call Meeting to order: The meeting was called to order at 10:00 am by Chairperson John Holdridge. Present: Supervisors Jan Way, John Koshnick and Dave Wilz Others present: Bob Bowen, Bob Enright, Robin Lipski and Greg Siplay Meeting was recorded – there was no one present to keep minutes. Dave Wilz wrote down any motions and prepared this summary of the minutes.
- Discussion of entire ATV Ordinance that was presented to the board for their review from the ATV Task Force. Other related issues discussed were safety of atvs, timing of board vote for possible acceptance, public information meeting, budget for implementation (signs/brochures) route alteration to current atv ordinance and other potential recommended changes to ordinance.

<u>Motion</u>: Modification of atv routes to only parts of Hull that are north of Stanley Street and west to the Wisconsin River as it relates to the Stevens Point, Town of Hull border and north of Highway 66. (Map of Hull labelled #1 was highlighted to show area recommended. Motion by John Koshnick, and seconded by John Holdridge.) Motion passed by unanimous vote.

Motion: Motion to make changes to existing atv ordinance to include the following.

- Section 6, F 3. Should have hours changed to "one hour before sunrise and until one hour after sunset";
- Section 6, F8. entire paragraph to be deleted due to change in state law;
- Section: Penalties include actual penalties and associated costs under s.23.23 (13) (a), Wisconsin statutes (on a separate sheet.)

Motion made by Dave Wilz, seconded by John Holdridge. Motion passed by unanimous vote.

Motion: Motion to make additions to the existing ordinance to include the following:

- Add section that states that any local atv club(s) will be active in the encouragement of
 the use of proper insurances, safety practices for all atv riders and become engaged in
 other issues relating to the overall use of atvs on Hull roads, as needed.
- Add section that stipulates that any cost associated with necessary signs and the proper installation of those signs and their related costs, be borne by atv clubs and the potential use of grants.

• If revised ordinance passes, implementation will be dependent upon publication of the ordinance. Criteria for "rescinding the ordinance" and a potential decision matrix, as it relates to Section 6 (F.) must be established prior to publication, proper signage must be in place prior to publication and any other requirements must be in place before publication. Weather may also play a part in the date of publication.

Motion made by Dave Wilz, seconded by John Holdridge. Motion passed unanimously.

<u>Motion:</u> Motion to postpone decision by Hull Board as scheduled on March 9, 2020, until Chairman Holdridge returns from trip. March 9, 2020 board meeting would be used to explain all changes to that point. The April board meeting on 4/13/2020, would be for voting on the ordinance and any other changes that might be made on the March 9 meeting. Public informational meeting or survey could be done in between these dates.

Motion made by John Holdridge and seconded by Dave Wilz. Vote as follows: Holdridge aye, Wilz aye, Koshnick nay, Way nay. Motion does not pass.

Motion to Adjourn by Jan Way, seconded by John Koshnick – unanimous vote.

Meeting adjourned at 12:44 pm.
