Chair Holdridge and Bob Enright, Vice Chair of the Plan Commission spoke at the meeting requesting Stevens Point postpone the purchase of the Kluck land and appoint representatives from Stevens Point to meet with representative from Town of Hull prior to any Common Council decision on buying the Kluck property.
