- > Jan Way explains American Rescue plan, \$545,000
- Dave Pederson-waiting for response from Solar Grant, could also be financed possibly through American Rescue plan
- > Clerk Holley- CT form finished by Accountant, Bill presented to Board

7. 10 Hour work day-Road crew

- How will day off be handled?
 Answer: Road crew response, Same as for Sat. or Sun. One person on call per weekend, Notify office of schedule
- ➤ Info is tracked back to 2014, 10 instances, occurrences after 3-8 times, Working till 4 would eliminate need of Call-time(Normal Office hrs)

9. Transitioning to Appointed Treasurer and Clerk

Per WTA Cannot lower compensation, benefits, etc. from Elected hire status

Must stay equal, No changes from hire, cannot lower

Treasurer position

- > Position will stay "AS IS", Weekly schedule stays the same
- > WTA suggests "Letter of Understanding for positions for Annual meeting
- > We Need "To Do" job descriptions for employees, Jim has provided his

- Dave Wilz-Pay/Benefits study needed for all positions, Surveys used for info
- No benefits
- > Hybrid position
- Letter of Understanding for Annual meeting
- > 1-3 year contract
- John Holdridge doesn't feel we need contract, Question Required by law? Answer-per WTA no
- Positions can be combined example- Clerk/Treasurer,
 Administrator/Clerk with auditing required
- Motivation for Appointed? Answer- Skills needed for positions
- > Financial assistance/expertise as needed by Jim
- Mission statement-"Here to Serve"
- Motion to approve Treasure position to Appointed by Dave Pederson, 2nd by John Koshnick
- Motion carried by Voice vote

Clerk position

- > Dave Wilz explains 2 issues-Pay, Benefits plan going forward
- Electors voted for temporary relief and pay Clerk for over 140 hours of Overtime. Voted on during Annual meeting
- > "Appointed positions were approved at "Annual Meeting"
- > Surveyed Data from "Like" towns, ex population, Benefits
- Jan surveyed 13 Towns, Dave also researched Appleton and local Plover and Portage county (\$40,000 minimum pay) (Clerk's office Assistant \$54,000)
- > Salaries-based on population, these were used for comparison
- > Benefits vary, State benefits good, Our Union benefits are very good
- ➤ Salaries varied from \$42,000 to \$52,000, Average \$48,000 Population average populations 3453-7691 residents
- Recommendations for Appointed Clerk position-see handout

- > Converting Salaried into Hourly, Covers OT with COVID and Elections
- > \$23.08 an hour, \$48,000 per year
- Currently \$18.47 Hour (Based on Salary)
- > Overtime will be preapproved
- Benefits will follow Employee Handbook as a guide with the exception of 3 week vacation per year as hired (Commitment) Accrual of sick days-Add sick days from previous year?
- > Future wage increases based on 3rd week of April
- Letter of Understanding to start, continued pay analysis, possible contract in future
- ➤ Merit based index-Act 10, Jan 1st 1.56% for all employees Clerk would increase to \$39,000, 18.75 hr
 - Both Jan and Dave came up with SAME proposed Sala
- > John Holdridge questions increase, Need to advertise for candidates to fill position, Questions any Commitments not met?
- ➤ Jan Way explains that Job offers are being made from other Towns.

 Also explains 2 positions in area that were comparable to position and paid in lower 50's
- Overtime was paid for 2020 per Annual meeting discussion
- Contract not necessary
- > Jim Kruziki states replacement and cost to replace position, Businesses
- ➤ pay well for these type of positions, Paying \$50,000 for similar position
 What should this position be paying? Don't look at increase
- > Research proves recommended salary
- > The Clerk is the lowest paid Full-time employee at Town of Hull

- > Janet was locked in as an Elected position with salary, 2 year cycle
- > Other positions might need adjustments also
- > John states Union benefits make a difference, advertise and get better candidates
- > Dave Wilz-WI is a Right to Work State, Have to show cause for change
- ➤ 40 people applied for Clerk's position, not all Hull residents, 3 eligible candidates, one backed out
- > Clerk left, No training, COVID
- Jan Way states "We just spent lots of money; machinery-\$, vs a person's Salary" (Human)
- > John Holdridge supports motion but stresses public concerns
- John Koshnick states that "Why pay lower Salary than Competitors?"
- ➤ New Salary will start April 20th
- Motion to approve new Clerk's Salary by Dave Pederson, 2nd by John Koshnick
- Motion carried by Voice vote
