Below I have outlined a process to better understand the Fire Department origin and current operation but also future operation and direction. This review is more

comprehensive than only looking at the Metro fire concept. Many of us realize the Hull Board has not had a comprehensive review of the Hull Fire Department and its operation for sometime (if ever). We have a self imposed deadline of July 9, 2013 to determine Hull's participation in the Metro concept. That date has been agreed to by both the Village of Plover and the city of Stevens Point.

Below is a suggested review process. I would invite your recommendations on how our approach could be improved. The primary investigators and reviewers would be Fire Chief Mark Kluck, Assistant Fire Chief Mark Fritsche, Assistant Fire Chief Ken Sadogierski, Janet Wolle Town Clerk, John Holdridge, Town Chairperson and board members as available would be similarly involved. I would envision a bench mark report at the June board meeting. We should have an informed discussion with the Fire Department and EMT personnel. A final report would be submitted at the July board meeting. I submit the following scope of the investigation:

- A. Authority/Legal Background
- 1) Origin of Hull Fire Department Legal status and social need Wisconsin law and Hull Board action
- 2) Relationship between Hull Town Board and Fire Department -administration and operations Authority and legal status of both
- 3) Contractual relationship to other area Fire organizations including MABAS, Mutual Aid and other intergovernmental commitment. Are there informal arrangements or formal agreements?
- 4) State and Federal laws relating to operational policies, administrative structure standard operating procedures, training and other rules regulations and requirements
- B. Operational Background
- 1) Hull Fire Department operations, trucks, equipment, training, staffing level, compensation, state highway accident intervention, water and other needs
- 2) Emergency Medical personnel and operation (ask same questions as in #1 above)
- 3) Federal, State, County, Local funding for Fire Dept/EMT operations
- 4) Assistance to other Fire Department and emergency personnel
- 5) ISO insurance rating and cost impact on households in terms of insurance rates
- 6) Fire Response time for Hull households
- 7) Monthly and annual data on Fire and EMT runs for 2011 and 2012
- C. The Future Challenges The Out Years
- 1) Major Issue staffing, equipment, financing, training going forward
- 2) The role and availability of the volunteers particularly during work days

- 3) Role of Hull Road Crew in emergency services (Fire/EMT responses)
- 4) Relations and involvement with Stevens Point Fire Department
- 5) Explore remodeling of Hull Fire Station
- 6) Potential new development and direction
- 7) The Metro concept and implementation, the contractual relationship, and other issues
- D. Summary/Conclusion/Recommendations
