Jim Warner – Last November when working election, the north end of the parking lot was very dark. The lot has to be illuminated better.

Chip seal bids received from:

Fahrner Asphalt \$158,129.00

Scott Construction \$159,583.00

Pete Kaminski:

- \$81,000 in budget for chip sealing
- Damage to roads outside of chip sealing
 - Want to do work on Evergreen Drive (180'); Torun Road (170'); Pioneer Road
- Recommend for chip sealing the following roads:
 Algoma Street, Blackberry Lane, Clark Street, Melrose Court, Lark Court, Westminster Court, Badger Avenue, Ben's Lane

P Kaminski, cost for aforementioned roads by Fahrner Asphalt - \$41,767.00 (does not include sweeping)

P Kaminski, Scott's bid for the same roads is \$41,056 (does not include sweeping) The difference is \$711.00 between the bids.

Chair Holdridge – what is your recommendation?

P Kaminski – go with the low bid of Scott Construction.

Supervisor Wilz – we put together a document we asked them to bid on. We didn't know what the price was going to be, we know what our budget is, but we know it is not enough to do the whole thing. But based on the job you put out to bid my understanding is, from looking at this, is Scott's the lowest one?

P Kaminski – Scott's is a little bit lower than Fahrner.

Wilz – so based off of these roads and the roads you put together for the clean-up, who is the cheapest one?

P Kaminski – Fahrner is.

Bryan Nevela of Fahrner – getting more product for less as Fahrner uses .35 application.

Chase Brochman of Scott's Construction – the .32 rate is sufficient.

Chair Holdridge – in the overall picture Fahrner is a little cheaper than Scott's, but the roads you are doing Fahrner is a little cheaper?

P Kaminski – Scott's is a little bit cheaper (\$722).

Chair Holdridge – the standard is awarding to the lowest responsible bidder.

Supervisor Pederson – I need some clarification. You said we have \$81,000 budgeted for chip sealing and you are talking about doing just a few of the roads and using \$41,000 for the other three roads. So you are taking money out of the chip seal budget for the other roads.

P Kaminski – it is called chip seal/road maintenance budget so it covers different things.

Holdridge – give us your recommendation again.

P Kaminski – go with the low bidder.

Holdridge – the low bidder is who?

P Kaminski – Scott's Construction.

Pederson – do we need to sweep all the roads?

P Kaminski – we are going to sweep certain roads where the traffic is on. It is \$105.00 per hour to sweep roads.

Pederson – depending on whether it is needed or is it

P Kaminski – correct. All of the roads mentioned are inside subdivisions and need to be swept.

Motion Supervisor Pederson, <u>accept chip seal bid from Scott Construction in the amount of \$41,056 as per recommendation by Road Foreman Pete Kaminski.</u> Second by Supervisor Way.

Barb Brilowski – looked at bids and came up with using numbers to do the following roads: Algoma, Badger, Blackberry Ln, Clark St, Lark Ct, Melrose Ct, Westminster Ct, Ben's Lane, Driftwood Drive, Pinewood, Pioneer, Duncan and Highland.

Scott Construction - \$81,308

Fahrner Asphalt – the aforementioned roads plus Golla Road for \$80,932

You could do almost all of the roads bid out. To me you could get more for your money, not knowing Pete was bringing up Evergreen and the other roads. That should be taken in to consideration and then the only roads not covered are Maple Bluff, North Reserve and Granite Ridge Road.

Holdridge – Pete is not going to use all of the \$81,000

P Kaminski – I would use \$41,056 right now. The sweeping would come out of the \$81,000 and the remainder would be used for the repairs of the other three bad spots for \$35,000.

B Brilowski – you don't have numbers for the bad spots now.

P Kaminski – I have close numbers of estimated cost:

Evergreen Drive \$10,000
 Torun Road \$5,000
 Pioneer Road \$20,850

B Brilowski – that is only from one company.

Holdridge – I would like to hear all of this discussed but we only have one road foreman and he is out there. Barb you have good input, Janet has good input and sometimes I even have good input. But at this point I am down to saying who is the road foreman, who is going to manage it and who is going to be responsible for it and as far as I know that is Pete.

Motion carried by voice vote.

09)2018 End-of-Year Budget highlights – Jim Kruziki, Treasurer Clerks note - Report in detail at end of minutes

Chair Holdridge – Jim's report is interesting especially the tax levy. Act 10 froze tax rates.

Treasurer Kruziki – in the earlier years we did not need to use the entire levy so we did not levy the maximum.

Supervisor Wilz – correct me if I am wrong, but it looks like we have split the operational levy from the debt.

Kruziki – that is correct. However, as far as the total levy

Wilz – it is pulled back in.

Kruziki – yes

Hull's tax rate is according to our debt and new debt

Wilz – Act 10 started in 2011. Operationally, we have less money today than in 2011.

Wilz - This is a good sheet because it shows what the base was and it really has not gone up to much except for any type of net growth. It also shows the debt service incurred per year.

Holdridge – with the 2018 budget we have revenues and expenditures. Where did we end up on December 31st after all the bills are paid, etc?

Kruziki – that is on the memo that shows a cash surplus of \$172,578.

Wilz – we were supposed to have \$78,000. The \$78,000 was in a line called contingency.

Kruziki

- In 2019 Hull started receiving personal property reimbursement
- In addition, we received \$47,000 from the City of Stevens Point as settlement in the Well #11 agreement. The settlement amount is in a reserve fund.

Motion Supervisor Wilz, <u>accept the report of Treasurer Kruziki</u>. Second by Supervisor Koshnick. Motion carried by voice vote.

LeRoy Pukrop of Town of Dewey was present. LeRoy is the Chair of Pok-A-Snoz Snowmobile Club.

✓ Saw Tracy Pelky of Portage County Planning and Zoning Department re: having a holding tank installed at Pok-A-Snoz Snowmobile Club building at 2390 North Second Drive

- ✓ Tracy Pelky indicated they are a good candidate for a holding tank as have small usage
- ✓ Holding tank will be on an alarm and will be pumped when alarm goes off
- ✓ The building is a groomer shed → equipment kept in shed
- ✓ It is an insulated shed with heat currently have only a porta potty
- ✓ Very few meetings are held in the building.

LeRoy Pukrop – if have problems with snowmobilers get the registration number that is on both sides of the snowmobile – it is like getting a vehicle license plate number.

- Problem with Highway 66 addresses, people cannot find the properties on Brychell

13) Hazard Mitigation Plan information from Bob Weinert, Portage County Emergency Management Coordinator – John Holdridge Hull Chairperson and Fire Department Leadership

Chair Holdridge – as a town we need to be prepared for any event in case of an emergency. We now have a generator that operators the entire building.

Assistant Fire Chief Fritsche, they are updating the countywide hazard mitigation plan – as far as suggestions from us, we need to know what is in the current plan.

- ✓ If we had a tornado in Hull and it took the municipal building out, what is Plan B? I agree without power for 5 days a generator is to help us but a lot of times when there is a tornado, a mass devastation, they shut the gas off
 - What do you have for a backup plan to run the generator?
- ✓ I am looking at major catastrophic hazards,
 - What if CN derails a train and we end up with a Weyauwega at Highway
 51 and the railroad tracks
 - What if the DuBay dam broke and water came rushing down how much of the town is going to be under water
 - I think these are the kinds of hazards they are looking at

Supervisor Pederson – I think essentially the plan in the past we needed:

- To inventory the kind of equipment we can get to an emergency
- > Have a chain of command as to who is going to make decisions about what
- ➤ I noticed they mentioned FEMA monies for tornado safe buildings; maybe we could work that in to a new firehouse

Holdridge – in order to get federal aid they had to have a plan. What does the town have as a plan?

Fire Chief Sadogierski – there are several books at the station. There is an operation plan; the town is divided in to geographical areas.

Holdridge – we need a plan, people to know about it and be able to respond.

Fritsche – I have seen the book. Somewhere along the line, the town board developed a Hull emergency operations plan. I assume that is a spin-off from the county plan.

Sadogierski – each municipality has its own operation plan.

Holdridge – let's put this on the agenda in the future. Can somebody from FD attend May 14 county meeting?

Clerk Wolle - according to the return call I received from Bob Weinert Portage County is looking for municipalities to attend the May 14 meeting. Mr. Weinert indicated they are really looking for one (1) big issue each municipality is concerned about.

Holdridge – we need to become involved.

Pederson – if we could respond to this with an email about potential hazards in our town that would be a start.

Holdridge – it would be accurate to say that the fire department and the Fire Chief in particular would be our contact.

Sadogierski – correct.

SUBJECT: 2018 End-of-year Budget Highlights

The attached year-end budget summary report shows the year 2018 completed with a cash surplus of \$172,578. Here are some key points to review regarding the 2018 year:

EXPENDITURES:

- Road projects consisted of engineering work on initial stage of North Second Street project for \$88,687
- A new salt-shed roof was constructed at a cost of \$16,197
- Fire Department purchase of new required air masks and tanks; the FEMA grant was not received so the Town financed the entire cost of \$81,231
- Fire Department building roof was replaced at a cost of \$51,828
- A full building generator was installed in the municipal building at a cost of \$35,108 and a new copy machine was purchased costing \$5,993
- Debt service increased by \$68,874
- Regular Operational costs were under budget by \$131,287
- Total expenditures were slightly under budget by \$119,925

REVENUES:

- Property taxes collected were slightly over budget by \$10760
- State Shared revenue was slightly over by \$1,271
- General Transportation aid and Rents were on budget
- A FEMA grant of \$128,000 for Fire Department equipment was not received
- Cable TV Franchise fees from Charter and newly installed Tomorrow River media were over budget by \$1,479
- Transfers Out to Designated Reserve funds from Well 11 settlement with the City of Stevens Point were \$47,000
- Total Revenues before borrowing was \$1886,919
- Borrowing for the year totaled \$246,000







5600 Block of State Highway 66 – Change addresses to Brychell Drive

May 7, 2019

A request was presented to us from Nathan and Jodie Groshek to change the address for the residents that reside on Brychell Drive. Currently, the addresses of those on Brychell Dr. are State Hwy. 66. Right now, the Groshek's address is 5965 State Hwy. 66. They would like it changed to 5965 Brychell Dr.

The reason for their request is no one can find them. They have built a shed on their property and are going to build a home this summer. Delivery companies are having a difficult time finding them.

I spoke to the Postmaster at Stevens Point. He has no problem with the change. The mailboxes would remain on State Hwy, 66, as the mail carriers do not deliver mail to dead-end roads any longer.

I spoke to Rod Sutter, Portage County Planning & Zoning, who oversees the addresses for 911. He feels the change is an excellent idea.

I then spoke to the other two property owners on Brychell Road. Mr. Check, 5960 State Hwy. 66 is building a shed at this time. The change would be easy for him, as he is not receiving mail at this location yet. I also spoke to Mr. Weiland, 5827 State Hwy. 66 who has lived at this location for many, many years. His main concern was getting his mail, as he would have quite a few address changes to make. The postmaster assured me his mail would be delivered for as long as it took for the transition. Therefore, Mr. Weiland is also agreeable to the change.

The process to make the change would be:

- Send a letter on Hull letterhead requesting the change of addresses from State Highway 66 to Brychell Dr. and the date we would like it to start to the Postmaster at the Stevens Point post office.
- Send a letter to each of the residents of Brychell Dr. informing them of the change and the date it will begin allowing them enough time to fill out the change of address request at the post office.
- Inform Rod Sutter of P.C. Planning and Zoning of the change. He will make the change in the 911 system.
- 4. I will do an address change for the Portage County Land Description Department.
- 5. Inform Hull's Fire Department.
- Inform Hull's Road Department. Hull receives road aid for Brychell Dr. so it is treated like all
 other Hull roads. There is a Brychell Dr. road sign in place. They will need to check if the sign is
 the reflective material required.

ORDINANCE 2018-1008 (Revised) Hull Road Maintenance, Reconstruction, Safety Committee (Hull Road Committee) Town of Hull

Background: The Town of Hull has approximately 82 miles of roads, a road crew of 4 full-time employees (4 of the 6 full-time Hull employees) and road related expenditure comprising 45% of the Town of Hull budget.

The Town Board of the Town of Hull, Portage County, Wisconsin, designates and ordains as follows:

Section 1. <u>Title.</u> This Ordinance is titled Hull Road Maintenance/ Reconstruction/Safety Committee (Hull Road Committee).

Section 2. <u>Purpose</u>. The Purpose of this ordinance is to establish a Hull Road Committee and set forth its organization, powers and duties to further the health, safety, welfare and wise use of roads in Hull to the benefit of current and future Hull residents and other users. The adoption and implementation of the Road Committee Ordinance provides significant citizen input to oversee road projects and usage in the Town of Hull and to advise the Hull Board of Supervisors of current and make recommendation for future road policies.

Section 3. <u>Authority/Establishment.</u> The Town Board of the Town of Hull, having been authorized by the Town Meeting to exercise Village Powers in 1967 to protect the health, safety and welfare of Hull citizens, establishes a Hull Road Committee. The Road Committee shall be considered the Town's official agency for road related investigations, analysis and policy development. The Hull Road Committee reports to and is advisory to the Hull Board of Supervisors.

Section 4. Membership. The Hull Road Committee shall consist of nine members appointed by the Town Board. The Chairperson of the Hull Board of Supervisors shall be the Chairperson of the Committee. The Chairperson may designate another Hull citizen to be Chairperson. Other elected or appointed officials of the Town may be appointed to the Committee except the Committee shall always have at least seven citizen members who are not Town officials. All appointments are subject to approval by the Hull Board of Supervisors. All Committee members shall be residents of Hull.

Section 5. <u>Appointment</u>. The Town Board shall appoint members of the Hull Road Committee in November 2018 or as soon as practical after adoption of this ordinance. The initial appointees to the Hull Road Committee shall be for two or three-year terms of office. Four (4) of the seven citizen members shall be appointed to three-year terms, three (3) shall be appointed to two-year terms. Thereafter, appointment will be for 3-year terms for citizen members. Elected official terms shall be the term of their respective office. All members shall assume their duties as Hull Road Committee members upon appointment.

Section 6. <u>Meeting.</u> The Hull Road Committee shall meet at least five times annually. All meetings are subject to the Wisconsin Open Meeting Law.

Section 7. <u>Compensation – Expenses.</u> No per diem allowance is authorized for members of the Hull Road Committee. However, the Town Board may reimburse for reasonable expenses and shall provide an annual travel stipend.

Section 8. Rules and Regulations. The Hull Road Committee may adopt rules for the transaction of its business subject to Town Ordinances and Wisconsin Law. A record of its resolutions, transactions, findings and determinations shall be kept. Official minutes of each meeting shall be kept and once approved, shall be filed at the Hull Municipal Building, maintained by the Hull Town Clerk, and shall be a public record.

Section 9. Experts and Staff. The Hull Road Committee may utilize experts as necessary. Their services shall be paid for as necessary and proper within the limits of budget appropriation in the Hull Annual Budget or approved by the Hull Board of Supervisors. At all times, finances appropriated for Hull roads shall be subject to the Town Board budget authority and regulations.

Section 10. Chairperson / Vice-Chairperson / Secretary / Officers.

- 1. <u>Hull Road Committee Chairperson</u> shall be appointed to a two-year term of office coinciding with the elected term of office. The Chairperson shall be subject to Town Ordinance and Wisconsin Law and provide leadership to the Committee. The Chairperson shall preside at Committee meetings, hearings, set meeting and hearing dates, establish agendas for meetings and ensure ordinance and laws are faithfully followed. The Hull Road Committee Chairperson shall be the Chairperson of the Hull Board of Supervisors or his/her designee.
- 2. <u>Vice-Chairperson</u>. The Hull Road Committee may elect, by open vote, a Vice-Chairperson to serve in place of the Chairperson when the Chairperson is absent or incapacitated for any reason.
- 3. <u>Secretary</u>. The Hull Road Committee shall elect, by open vote, a Secretary. The Secretary may be the Hull Town Clerk or other Town employee as determined by the Committee.

Section 11. Committee Objectives.

- a. Review, revise as needed, implement and monitor Hull road safety plan.
- b. Review, revise as needed, implement and monitor Hull Weight Limit Ordinance.
- c. Review, revise as needed, and monitor Hull road ordinance and policies including but not limited to the driveway right-of-way and snow plowing policies and ordinances.
- d. Identify, review and implement a five-year road reconstruction plan for the Town of Hull.
- e. Review and approve Hull's annual seal coating/chip sealing maintenance plan.
- f. Monitor and review Hull's road crew annual inspection of roads.
- g. Review annually policies and ordinances pertaining to Hull roads
- h. Provide an annual report on the status of road maintenance, reconstruction and road safety in the Town of Hull at Hull's annual meeting in April. As appropriate, make recommendation of improvements to road maintenance, reconstruction and safety to the Annual Meeting.
