RE: Protection of Ground Water in Portage County

The recently reported fuel spill at The Store on Highway 10 and Badger Avenue brings attention to water quality concerns and Portage County's role in protection of ground water.

The Town of Hull Board asks Portage County to be vigilant with respect to water quality, especially in areas of development that pose risk to water safety. Two areas in particular are the Kwik Trip on Old Highway 18 near Highway 10 and the aforementioned The Store on Highway 10 and Badger Avenue. Both of these gas stations are built in wellhead protection areas and the latter is located adjacent to wetlands that feed the aquifer providing municipal well-water to Stevens Point households and to 2,000 plus Hull residents.

The wellhead protection area in which these gas stations are located are intended to protect the well water of Stevens Point, not residents of Portage County who live in other municipalities or unincorporated areas.

The Town of Hull Board requests that Portage County leaders develop a community approach to water protection that includes advocacy of water protection for all residents of Portage County, not just those who reside in Stevens Point or in other areas that have municipal systems.

The Town of Hull Board asks that Portage County water specialists be directed to take strong professional positions on water protection and serve as advocates for County water quality protection.

With respect to the two gas stations built within wellhead protection areas, the Town of Hull Board requests support from Portage County for the following:

- The installation of county monitoring wells in locations designed to detect contamination of water in Portage County.
- That Portage County professionals be knowledgeable about the protocols for water testing at gas station type establishments.
- Frequent testing at regular intervals of the aquifers fed by the wetlands adjacent to The Store on Highway 10 and Badger Avenue.
- That the same information on water testing sent to the Department of Natural Resources and the City of Stevens Point be sent to Portage County officials including municipal officials and residents potentially affected by contamination events.
- That an event management plan be developed to inform County residents of what to do when a spill or leak of contaminating substances has occurred.
- The development of a clear statement of responsibility for spills or leaks, that cover cleanup, the provision of safe water, and impact on property values.
- Testing of private wells whenever contamination has been detected in gas station monitoring wells (including the recent spill at The Store).
- The installation of monitoring wells in locations judged appropriate by Portage County water specialists for the protection of County water.
- The establishment of an emergency water plan for County residents in the event of contamination of private wells.

Thank you in advance for your attention to this critical issue. Please provide a timely response to this Town of Hull proposal.

14) Hull government leadership on R-2 Single Family Zoning revision

RE: Hull's Leadership on Revision of R-2 Single Family Residential Zoning District

Recently Portage County officials have suggested the Town of Hull provide leadership in the revision of the R-2 Single Family Residential zoning classification.

Hull's experience with the R-2 Single Family district has been expansive and troubling beginning with 527 Maple Bluff Drive and continuing with 5116 State Hwy. 66. Hull officials recognize that Portage County personnel enforcing zoning classifications need to follow the zoning code as it was approved of by the Portage County Board. From Hull's perspective, the current R-2 Single Family code needs to be revised to better meet the standards of the neighborhoods.

I envision Hull's role and the following process:

- 1. Approval of the rezoning process and support from the Portage County Executive, the Portage County Planning & Zoning Committee and the Portage County Planning & Zoning Department.
- 2. A commitment from the Portage County Planning & Zoning Department to provide personnel to assist the Hull R-2 Zoning group in its revision efforts.
- 3. Creation of a task force consisting of representatives from the Hull Plan Commission and Hull R-2 residential neighborhoods to develop the standards for the revised R-2 zoning code. Representation from towns having R-2 zoning districts will be asked to participate.
- 4. Approval of the revised zoning code by the Hull Plan Commission and Hull Board of Supervisors.
- 5. Submission of the R-2 zoning code revisions to the Portage County Planning and Zoning Committee for approval and ultimate approval by the Portage County Board of Supervisors before implementation.

I will be meeting with the Portage County Planning & Zoning Committee on Tuesday, July 28<sup>th</sup> to present this proposal.

I submit this preliminary outline of the process for your review and approval.

15) Revision of Hull Weight Limit Ordinance I-39 access

Dennis Hintz, Chairperson of Town of Dewey, was in contact with John Holdridge re: Jim Grezenski Forest Products firm on County Road X. Chair Hintz requests Grezenski vehicles be allowed to use North Second Drive/Casimir Road from County Road X to I-39. Currently Hull's ordinance states use of Hull road(s) permitted to those traveling to property in Hull, not driving through.

Suggested revisions to the ordinance are in red and underlined.

- C. Vehicles with Hull weight permits may be required to travel no faster than 25 mph on Hull Roads when such limits are imposed as a condition of receiving a permit.
- D. Special permits are required for projects involving frequent heavy loads exceeding Weight Limit and frequent trips from one specific location on Hull roads including but not limited to construction of ponds and logging operations. Special fee and bonds may be imposed to cover Hull cost for road monitoring and potential damage to roads. Such roads may be designated as "haul roads" and be marked and monitored accordingly. Wisconsin DOT procedures for "haul roads" will be followed as closely as possible.
- E. Businesses located in the Town of Hull operating vehicles exceeding the weight limits will be required to have a special permit. Such permit may be issued semi-annually or annually.
- F. Owners and/or operators of trucks exceeding the weight limit (WL) who store their vehicle(s) at their residence or place of business in the Town of Hull will need a special permit that may be a semi-annual or annual permit. Semi trucks, for example that exceed the WL, will need a permit.
- G. Vehicles exceeding the weight limit traveling from one municipality to another through the Town of Hull but not delivering product/service to Hull households/businesses shall not use Town of Hull roads. No permits exceeding the Class B or seasonal 7 ½-ton weight restriction will be issued.
- H. I-39 Access to the I-39/Casimir Interchange.

  Overweight vehicles exceeding the Class B Weight Limit using the I39/Casimir Interchange for a destination outside of the Town of Hull will be
  granted a permit to travel Hull roads on a case by case basis. A permit may
  be issued on a daily, monthly, quarterly or annual basis. No permits shall
  exceed a year. The spring 7½ ton weight restrictions will apply. Other Hull
- I. Because of the variety of road surfaces and sub-soils and state/federal requirement, the Town of Hull reserves the right to impose emergency restrictions on Hull roads that

road restrictions may also apply as stated on the road permit.

becomes effective upon posting. Special WL, for example, may be imposed west of I-39 at 7 ½ ton during the non-spring period because of road deterioration.

# **Section III.** Weight Limitation

The Hull Road Foreman is responsible for designating roads and imposing weight limits subject to review by the Hull Town Board.

# A. Year Around Limitation

All Town roads within the Town of Hull, Portage County, Wisconsin are considered Class B roads as defined by Wisconsin Statute. Class B roads limit usage without a permit to 60% of the weight authorized for Class A road. Class B roads have a maximum total weight limit of 48,000 pounds. Trucks exceeding the applicable weights are required to have a permit from the Town of Hull to operate on Hull roads. Class B roads require an axle weight not to exceed 12,000 lbs (60% of Class A axle weight of 20,000).

- B. Special Weight Restriction (see attached flow chart)
- 1. Any motor vehicle whose operation is pickup or delivery, including operation for the purpose of moving or delivering supplies or commodities to or from any place of business or residence that has an entrance on a Class "B" highway, may pick up or deliver on a Class "B" highway provided they meet the gross vehicle weight limitations. However the following special weight limits shall apply and require a permit to operate:
- (A.) Operation on listed roads (new roads) is limited to a maximum of 15,000 lbs. per axle. *Examples:*

Quad-axle (5 axles) x 15,000 lbs. / axle = 75,000 lbs.

Tri-axle (4 axles) x 15,000 lbs / axle = 60,000 lbs.

# <u>Listed roads are the following:</u>

- ➤ Wilshire Drive North Point Drive to Jordan Road
- ➤ Jordan Road County Road Y to North Second Drive
- ➤ North Reserve Drive City limits to Jordan Road
- ➤ Brilowski Road State Highway 66 to Walter Street
- ➤ Old Highway 18 U.S. Highway 10 E to City Limits
- ➤ Golla Road Maple Bluff Road to Brilowski Road
- ➤ Old Wausau Road City limit to Dubay Avenue
- North Second Drive City limits to County Road X

(B.) Operation on non-listed roads (old roads) is limited to a maximum of 12,000 lbs. per axle. *Examples:* 

Quad-axle (5 axles) x 12,000 lbs. / axle = 60,000 lbs.

Tri-axle (4 axles) x 12,000 lbs. / axle = 48,000 lbs.

Non listed roads (old roads) are all other Town roads not scheduled as a listed road in III.B. 1 (A). Examples of all old roads include but are not limited to:

- Granite Ridge Road
- > North Star Drive
- > Torun Road North of Jordan Road
- Casimir Road
- North Second Drive City limits to County Road X

# 2. Excessive Weight / Frequent Trips

The Town of Hull on a case-by-case basis will consider permitting vehicles that involve excessive weight/frequent trips above the limits defined in Section III.A and B.

Request to exceed the limitations may require special consideration as a "haul road" requiring additional documentation and observation. Pre-photo filming and post photo filming may be implemented to record any damage to Hull roads. The cost of these
