Chair Holdridge:

Pg 3 – Amherst Telephone received a broadband grant for expansion of high speed internet in the Town of Hull. Grant total \$170,000.

Page 2 & 3 - Resolutions suggested for future board agenda: Redistricting and Climate Change

Page 4 – item 9 add to minutes "Motion Carried".

Pg 9 – Have not been following correct policy for paying of bills due to concern of receiving interest charges on late payments.

Pederson: Pg 3 have a question about the word doomage – is that a word?

Wolle: yes, that word has been used by assessors who have not been allowed in dwellings to view for assessment purposes. They place a higher, or doomage, assessment on the property. Assessor's then hear from the property owners.

Chair Holdridge:

- Mark has served as Fire Chief since 1999
- Thankful for Mark's service to Hull
- Tasks are not always easy

Supervisor Wilz:

- Can't ask for more dedication
- -Leaving in less than a month and Hull needs to allow Mark to file his mileage reports and get paid the mileage policy is currently being worked on
- Board needs to put someone in charge for an appropriate gift

Ken Sadogierski and Mark Fritsche – the Fire Department has a plaque for Mark.

Holdridge – pictures of each chief should be placed in the lobby.

Fritsche – we have pictures of the chiefs at the fire station that can be scanned

Motion Supervisor Wilz, **communicate with Mark Kluck and tell him to submit his mileage up to last date.** Motion seconded by Supervisor Pederson. Motion carried.

11) Harter's Contract Renewal – appointment of review group

12) Storm Branch Pick-up – final day

Holdridge: 175 loads of branches were picked up following the June 12, 2017 storm.

Kaminski – have not picked up branches for about a month; however have 3 more properties with branches to pick up. I would like storm related clean up to end on September 1, 2017.

- Will have all branches cleaned up by then.

Motion Supervisor Pederson, <u>September 1, 2017 is the end of brush pickup</u> <u>from the June storm damage.</u> Motion seconded by Supervisor Way. Motion carried.

13) Badger Ave. and Highway 10 E Stop and Go Light – Board Position

The Hull Board accepted the petitions from citizens requesting traffic lights at Badger/Highway 10 E intersection at their July 10, 2017 board meeting. Bob Enright and Bob Berg were in attendance, they were signers and circulators of the petitions.

Holdridge – not long ago there was another accident at Highway 10 E/Badger Ave when a person pulled out from Badger Ave turning east on to Highway 10 E and was hit by a vehicle going west. Bob Enright has pictures.

Wisconsin Department of Transportation (WDOT) held a meeting at Ben Franklin on July 18 and formally removed the southern Highway 10 E by-pass from happening. Traffic will continue to grow on the current Highway 10 E because of this.

Follow-up needs to be done with Senator Testin and Representative Vander Meer.

Way: Alderperson Mary Kneebone was in touch with Jan requesting a study or public hearing be done and wondered if the town would participate in this with the city.

Holdridge: don't have a problem with that.

Holdridge: need to pass the petition on to Mike Wiza, WDOT, governor and representatives.

Motion Supervisor Way, the Town of Hull Board formally request Wisconsin Department of Transportation install traffic lights at the Highway 10 E/Badger Avenue intersection. Motion seconded by Supervisor Pederson. Motion carried.

Wilz – instead of leaving on the end of the 4th, Mark Kluck is leaving 1 minute before the 4th begins. In other words, he is not going to be a Fire Chief on Labor Day, he is going to be on vacation!
