08) Resolution to Create a Nonpartisan Procedure for the Preparation of Legislative and Congressional Redistricting Plans

Supervisor Way:

- A lot of counties are using the same resolution
- Last census redistricting found to be illegal and remains in the court
- The resolution is as follows:

WHEREAS, Pursuant to Article VI, Section 3 of the Wisconsin Constitution, the Wisconsin Legislature is directed to redistrict legislative districts "according to the number of inhabitants" at its next session following the decennial federal census. At the same intervals, the legislature also reapportions congressional districts pursuant to federal law, and

WHEREAS, historically legislative and congressional plans in Wisconsin have been subject to partisan influence that put the desires of politicians ahead of the electoral prerogative of the people, and

WHEREAS, the state and congressional districts belong to the citizens of Wisconsin and should be designed with the best interest of Wisconsin's democracy and its citizens, and not be a tool used by those in power to protect and bolster their power, and

WHEREAS, a panel of federal district court judges has ruled that the redistricting done in Wisconsin in 2011 was unconstitutional. Legal cost in defense of the 2011 redistricting has already cost taxpayers in excess of \$2.1 million, with still continued litigation at the Supreme Court,

BE IT RESOLVED, that the Town of Hull Board of Supervisors, County of Portage, Wisconsin, calls upon the State Legislature, prior to Election Day of November 6th, 2018, to pass legislation that creates a fair, nonpartisan procedure for the preparation of legislative and congressional redistricting plans, that promote more accountability and transparency, and prohibits the consideration of voting patterns, party information, and incumbents' residence information or demographic information in drawing maps, except as necessary to ensure minority participation as required by the United States Constitution.

BE IT FURTHER RESOLVED, that the Town of Hull Clerk is hereby directed to send a copy of this resolution to the Governor of the State of Wisconsin, the Wisconsin Counties Association, the Wisconsin Towns Association, the Wisconsin League of Municipalities, all members of the state legislature, and to each Wisconsin County.

Motion Supervisor Way, second Supervisor Pederson, <u>adopt the Resolution to create a Nonpartisan Procedure for the Preparation of Legislative and Congressional Redistricting Plans.</u> Motion carried.

09) Application for Hull Adopt a Road program - North Second Dr. (1 mile) from the Intersection of N. Second Dr & Evergreen Dr to Rocky Ridge Rd. - Group Name: Stevens Point/Esteli Partner Cities Wisconsin/Nicaragua Partners

Stevens Point/Esteli Partner Cities Wisconsin/Nicaragua Partners applied to become part of Hull's Adopt-a-Road program by adopting North Second Drive from the Intersection of North Second Dr. & Evergreen Dr. to Rocky Ridge Rd.

Patti Rous, group member was present and stated they plan to clean this section of North Second Drive twice a year.

 - Receive \$5,000 from Portage County Highway Bridge Aid
 - o In 2019 put overlay on with the North Second Drive project

Motion Supervisor Pederson, <u>approve the time line for North Second Drive</u> <u>project</u>. Motion seconded by Supervisor Wilz. Motion carried.

12) Resurfacing of Torun Road and the impact on abutting driveways – John Lawlis

John Lawlis was called out of town and requested via Barb Brilowski, the resurfacing of Torun Road and the impact on abutting driveways be tabled tonight and placed on the October agenda.

Discussion:

- Correspondence was sent to all residing on Torun Road having cement driveways
- Unfortunately John Lawlis who resides in Stevens Point did not receive the correspondence.

Email from Dave Glodowski, Hull engineer reads as follows:

Following is some date / history for concrete driveways in Hull:

- Per State Statute Chapter 82 The Town of Hull is the maintaining authority for roadways and has the ability to maintain as needed and as determined, for roadway purposes and for the good of the traveling public.
- The typical width of maintenance authority is 66', 33' from the existing centerline
- Based on my 25 years of road designing and construction management experience, it is standard practice to replace the existing surface of driveways with the same material as the new mainline roadway surface. This is especially true within the limits of the existing right-of-way
- Many towns restrict the driveway surface material to be gravel or asphalt, within the existing right-of-way. Concrete driveway connections to the town roadway is not allowed, or is at the owner's risk to not be replaced with future roadway improvements
- Recent Town of Hull examples of this:
 - In 2017, there were approximately 7 concrete driveways on Torun Road that were replaced with asphalt for the driveway connection, as the roadway was resurfaced with an asphaltic overlay. This work was all within the existing right-of-way.
 - In 2016, on Pinewood Drive, there was an existing concrete driveway replaced with a double sealcoat surface for the driveway connection, as the new roadway was surfaced with a double sealcoat
 - For the past 10-years of bidding and building roadway projects in the Town of Hull, I do not recall ever bidding out or hiring a contractor to replace a concrete driveway with concrete. All

driveways impacted by the road projects were resurfaced with gravel, sealcoat, or asphalt.

04) Ordinance Authorizing Alternative Claims Procedure (payment of bills/vouchers)

Clerk Wolle presented the Alternative Claims Procedure ordinance as follows:

2017-0911

60.44(2) WI. Stats. Ordinance Authorizing Alternative Claims Procedure

SECTION I - TITLE AND PURPOSE

This ordinance is entitled the Town of Hull Alternative Claims Procedure ordinance. The purpose of this ordinance is to authorize an alternative procedure for approving financial claims against the town that are in the nature of bills and vouchers.

SECTION II - AUTHORITY

The Town Board of the Town of Hull, Portage County, Wisconsin, has the specific authority under s. 60.44(2), Wis. stats., to adopt this ordinance.

SECTION III - ADOPTION OF ORDINANCE

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, establishes an alternative procedure for approving financial claims against the town that are in the nature of bills and vouchers as provided in this ordinance.

SECTION IV - APPLICABILITY

Payments of claims against the town may be made from the town treasury under the procedure established in Section V for bills or vouchers that are of a routine nature, namely: payroll, payroll taxes, retirement, health insurance premium, life insurance premium, Income Continuation Insurance, deferred compensation, union dues, utilities, fuel, refuse/recycling/transfer station, assessor, credit card bill, water. Or such vouchers that arrive that must be paid before the next board meeting.

SECTION V - PROCEDURE

A. Subject to the restrictions under Section IV, the payment of a claim against the town may be made from the town treasury if the town clerk approves in writing the claim as a proper charge against the town treasury. A claim against the town is a proper charge

against the town treasury if the clerk determines that all of the following conditions have been met:

- 1. Funds are available under the town budget to pay the bill or voucher.
- 2. The item or service covered by the bill has been duly authorized by the town board, or an authorized town official, agent, or employee.
- 3. The item or service covered by the bill or voucher has been supplied or rendered in conformity with the authorization.
- 4. The claim appears to be a valid claim against the town.
- B. The town clerk may require submission of proof to determine compliance with the conditions under subsection A prior to approval. (For example, the clerk may require verification of quantity, quality, etc, by another town official or employee.)
- C. After determining that the conditions under subsection A have been met, the clerk shall indicate approval of the claim by placing his or her signature on the bill or voucher. Upon approval of a bill or voucher under this procedure, the clerk shall prepare and sign a check and have it countersigned by the town treasurer and town chairperson, pursuant to s. 66.0607, Wis. stats. The treasurer shall then mail or deliver the completed checks to the appropriate parties.
- D. At least monthly the town clerk shall file with the town board a written list of claims approved pursuant to this ordinance. The list shall include the date paid, name of claimant, purpose, and amount.

SECTION VI - SEVERABILITY

If any provision of this ordinance or its application to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of this ordinance that can be given effect without the invalid provision of application, and to this end the provisions of this ordinance are severable.

SECTION VII – EFFECTIVE DATE

This ordinance is effective upon posting in three places.

Treasurer Jim Kruziki, the bill paying procedure has been an on-going issue for over a year. Hull has been in violation of state law. This procedure allows for payment of bills/vouchers that are of specific nature prior to board approval.

All checks are signed by the clerk and treasurer. Unless the board approves otherwise, all checks must also be signed by the Chairperson.
