- Heidi explains absentee ballot processing, public is welcome to view Absentee processing at Election
- Security during Election, No firearms allowed, Open or Concealed carry, New signage needed, Hire security for Election (Plain clothed) \$75 hr Decision is given to Election staff
- Supervisor Way: Town of Hull needs a Policy or Ordinance

  - Replacement of system as is, update existing cameras (View) \$14,000 w/maintenance (Batteries)
  - 2. 360 cameras on 4 corners of building \$18,000 w/maintenance, less cameras, more view from cameras
  - 3. Thermal system, "State of the Art", Takes temperature, photo upload, records data
- > Do we need this type of system? Needs to be included in 2021 budget
