Brilowski:

- PSOL has offered \$5,000 to serve Hull as owner lives in Hull and willing to offer the service to Hull – the company has gone worldwide and does not take on small businesses

- Judy is checking with Human Resources Department at the Stevens Point School District as she heard the district will extend coverage for 60 days

- Feel very important any cost relating to health insurance coverage be reimbursed to Judy by Hull

BE IT FURTHER RESOLVED, that Portage County Emergency Management will submit, on behalf of the Town of Hull, the adopted All Hazards Mitigation Plan Update to Wisconsin Emergency management and Federal Emergency Management Agency officials for final review and approval.
