 - ✓ Will add lights to the municipal building and upgrade existing to brighter lighting \$697.00 for high sodium (includes installation) will be on a switch as lights will only be used for voting
 - ✓ If city lot across the street from the municipal building is used for voting look at portable lighting
 - o Once get generator could plug in a light as long as it is locked down

J Holdridge – is there interest in going back to the Fire Station with voting?

Marilynn Kranig – No

Dave Wilz – we voted as a group to pursue this and move in this direction.

- Talked with Pete about the safety issue of the walk
- Concerned about if we had a February election whatever we had down as a surface could that be made safe enough with ice buildup and snow
- To lay cement down on first try are you getting it in the right place?
- Assured if put granite down and packed it really well, regardless of what the weather was that day the walk could be made safe for the people
- From that standpoint feel comfortable we can go the cheaper route until we really know what we are doing – we have had some elections – then we can do something more permanent if we wanted to
- As far as handicapped people needing assistance through the front door, if we have a good solid surface, concrete, granite whatever it is, they are prepared for that

- The handicapped are not the ones I am worried about, they know they have issues, it's the 60 some plus generation that still think they are 30 and they slip on an ice patch

Marilynn Kranig why a cement sidewalk is necessary:

- Close to 1/3 of our voters are elderly use canes, walkers or need assistance walking because of poor balance
- \$19,000 was allocated for a very necessary warning siren while those of us who work at the polls are asking for a cement sidewalk for the safety of the voters and which would not cost anywhere near \$19,000
- A granite walkway was suggested ask the ladies on their way to work how they feel about their high heels sinking into red granite and possibly damaging their expensive shoes
- Red granite dragged in to the building and on to the carpeting will stain the carpet red
- Our own crew could probably do the cement work so a contractor is not needed
- 2 generators are being discussed and they are necessary but a cement sidewalk will get a lot more use than the generators
- A safety committee was formed in the town to address safety concerns does this not apply to this building?
- As said at a previous meeting we are all capable of doing our best if you just let us continue to do our jobs
- Please seriously consider the cement sidewalk with the concerns of safety

J Holdridge – The Public Safety Task Force is really meant to deal with bikers, walkers and vehicles on public roads.

Dave Pederson – how well does the granite compact? Marilynn brings up the concerns about heels

Pete Kaminski – want to dig out the sod about 4" and put it 4' wide and 36" thick. We will get a roller from Stuczynski – the path will be as flat as the table. If it was a warmer spring

D Pederson – thawing.

P Kaminski – thawing, some people weigh 200 lbs. If it got muddy out there you would have to put something else down. Granite can be salted if it got slippery.

D Pederson – it would be sufficiently above the sod so that it would drain?

P Kaminski – it would be tapered so if it does melt the water would run off. I can mow over the path in the summer time.

J Holdridge – are there other things that need to happen in side this building in the garage area?

Janet Wolle – we will have something down on the floor in the garage. We will find something to drape off the office area.

J Holdridge – how do you deal with citizens who do not come in to vote? The front door will be the exit door.

J Wolle – that is correct.

J Holdridge – that probably will not be a problem at the February election but certainly will be a problem when you get in to the Governor and Presidential elections. If you have the office open those people will not go around and come in here?

J Wolle – no they will not. We will have signage on the door or out by the parking lot that would indicate a certain door for office use only.

Mel Bembenek – had granite at his home for 2 years and if you get sloppy weather it is dirty and does stain. After 2 years granite out and blacktop in. The only place for granite is on a regular road. Big chunks stay for awhile and then crumble. I would not have granite anywhere around my area.

D Pederson – there is a limestone mix that when it sets up it gets a lot harder.

P Kaminski – has some limestone but it has sharp edges (3/4 inch). It is a gray rock mixed with clay mat.

M Kranig – have had limestone in driveway for 18 out of 20 years – it is finally breaking down. You could feel it through your shoes. Now that it is broken down it is almost like cement.

D Wilz – have seen limestone but a smaller stone – instead of sand when putting in pavers they use gray limestone and pack it and it gets hard. There are probably other products.

D Pederson – coming off the side of the sidewalk in front of the building is a shorter distance – I like the idea of coming off the parking lot but look at other options.

J Holdridge – want to know why we don't close down the Town of Hull on Election Day. Carol of the Wisconsin Town's Association said closing the building makes a lot of sense. Then you are not mixing activities.

J Wolle – I understand that and that is the reason we have continued down at the Fire Department. As clerk I need someplace to work because of the availability requirement for people calling regarding absentee ballots.....

J Holdridge – can't you still do that back there?

J Wolle – I will continue to do that function in my office.

J Holdridge – that is related to voting.

J Wolle – understood however as Hull has full-time staff, people will naturally call especially due to the new election laws – there will be a lot of questions. Going into April there will be more requests for road permits. We are answering the phones so the poll workers do not thinking about the calls coming in. Could there be other things that come up? Yes. Not a lot.

M Bembenek – for things relating to voting, you will be here and if there is something that could come up, you will be here – it will be like it is open.

M Kranig – simply because the office is closed does not mean they will not get phone calls. Like it or not people will call about dogs, people on the planning department, at the fire department, etc. J Holdridge – if someone wants to come in to get a dog license say this is Election Day please come in tomorrow.

J Wolle – that is true and by the time we are in to April the majority of the dog licenses will have been issued. There will be, however, those coming in late – that is simply what happens.

- ✓ The majority of the business in the office on Election Day will relate to elections
- ✓ As mentioned before, Barb and I can also watch what is happening, help with getting voters in to the correct lines and make things are moving along as best as we can.

- ✓ We are all working together for that common goal of running the election.
- J Holdridge the part in the meeting room has to be guiet right?
 - ✓ Recall when the Republicans had inspectors literally looking over the shoulder of the poll workers
- J Wolle they were poll watchers. I anticipate we will have poll watchers as well this year
 - Poll watchers are allowed to look at the poll books
 - > They are supposed to, however, be very quiet and that was a problem as they were not

M Kranig – talking among people waiting to vote and poll watchers will have to be outside of the area for voting.

J Wolle – they will have to leave

D Pederson – is the problem with taking phone calls in here, the noise level?

J Wolle – we will make sure the phones are turned off in the voting area.

D Pederson – taking the calls in the back two offices won't interrupt the voting?

J Wolle – that is a reason we want to drape off the office area to eliminate as much as possible phone calls being handled by Barb and me.

- Pete has looked at the bell ringing in the bay and will be taken off so there will be some noise but limited
- For citizens coming in for non-voting business there will be signs directing them down the hallway to the office door we have talked about having a Dutch door installed
- These are things we have been talking about so we can make this work for everybody

J Holdridge – there is a sign indicating the capacity in the meeting room is 38. Barb asked why we did not put an emergency exit there (take out the window). If we do that it increases the capacity to 60. Why is that?

Mark Kluck – because you have another way out. There would be 3 doors instead of 2. The size, the height of the door, if it is wheelchair width makes the difference.

D Pederson – a single door?

M Kluck – yes.

J Wolle – a single door would not increase the capacity to 60 would it?

D Wilz – I thing you have to have a double. Someone should check that.

Mark Fritsche – a door could be put in like you see in a department store that is inaccessible from the outside – it is am emergency exit only.

M Kluck – it does not have to be a usable door until there is an emergency.

D Wilz – what does the weather do in terms of planning on putting down granite or some other substance.

Pete Kaminski – we need to get it in right away before the ground freezes. Once the ground freezes nothing can be done until it thaws.

M Kranig – took upon myself to call County Concrete and asked if you could put a cement sidewalk in at this time of the year. They said yes you can but you have to cover it with straw for 28 days to cure slowly. As long as the ground is not frozen 6" deep you can lay cement.

D Pederson – as long as you keep it warm enough so the chemical action

P Kaminski – the path is 48" wide.

J Wolle – would like to see a couple of temporary handicapped signage on the garage bay door.

D Pederson – need good signage. Is there a possibility of looking at different grades of limestone mix?

P Kaminski – will make some calls and look in to it. If a decision is made now, and later next fall if we decide we want something more permanent the granite or whatever material is used can be taken out and cement put in.

M Bembenek – whatever is installed it has to be wheel chair assessable width.

Motion Pederson, second Wilz, <u>explore surfaces possibilities</u>, <u>Pete report back to John and Mel and come up with a temporary path.</u>

M Kranig – can I ask that you not go with the granite?

D Pederson – I think we have ruled granite out.
