# 10. Recycling Special fee

- ≽ \$11,443 in Budget for increase, Recycling is expensive, suggested to
  be paid by TOH this year, (Sanitation line on Budget)
- Will have to be a Special charge on TOH tax bills (Aprox 2200 homes and 3000 parcels), small fee \$2.09 per person
  Cannot be put on Tax Levy
- > Public needs to know these costs are rising

- > TOH will need to address next year
- ➤ Motion to include Recycling fee in 2022 Budget by Jan Way, 2<sup>nd</sup> by Robin Lipski

- Questions: law enforcement, use of roads, control of traffic, safety.
  Amy explains process of run and trained volunteers are used
- > Race starts at noon through 2:00PM, 200-250 runners
- > chalk used on roads no paint

### 12. Slow Children signs

- > Signs are helpful
- Too many signs? Residents don't read
- > Signs are not always the solution
- Uniformed traffic control doesn't recognize this sign
- Pete is asking for direction: Speed limit is 25 mph, speeding is an issue in subdivisions, 50% of TOH are subdivisions
- > Parents feel better with signage
- What are the time frame of sign placement?

- ➤ Recoop the cost of signs? Charge for signage? \$25 sign, \$20 post, contracted time? Costs for TOH are going up!
- > Needs base approach needs to be used?
- > Log used for signs with dates of installation
- Update signs on use and time needed
- Motion to approve use of Slow Children signs on a as needed basis with Pete's criteria being used by Mark Fritsche, 2<sup>nd</sup> by John Koshnick
